Type: Stat-Rite® S-1112M is an *Inherently Dissipative Polymer (IDP)* masterbatch specifically developed to impart permanent static dissipative properties to polyethylene resins. **Stat-Rite® S-1112M** uses Lubrizol's proprietary Stat-Rite® IDP technology to provide permanent static dissipative protection. Blends of **Stat-Rite® S-1112M** with PE resins are injection moldable or can be extruded into the desired products. Typical loading of 20-35% will impart surface resistance of 10⁹ - 10¹¹ ohms to the final products.

Applications: Cleanroom components for packaging and cleaning, tote bins, part trays, tubing, sheet for thermoforming and prototyping

Supply Form and Standard Packaging

• Stat-Rite® S-1112M is supplied in pellet form and packaged in 50lb. bags or 1,000lb. boxes.

Material Preparation

- Prior to processing, **Stat-Rite® S-1112M** must be dried at 180°F (82°C) for 4-6 hours or overnight at 150°F (66°C)
- It is recommended to dry the material in a desiccant type dryer. Target dew point should be -40°C.
- Depending on the applied processing technique, the maximum moisture level should be 0.02%

• Stat-Rite® S-1112M can be processed on any conventional extruder or injection molding machine.
